JULY 1, 2014

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TOWN OF CAPE CARTERET, NORTH CAROLINA, that pursuant to G. S. 159-16;

SECTION 1. The following revenues are estimated to be available in the **General Fund** for the Fiscal Year beginning July 1st, 2014 and ending June 30th, 2015.

SECTION 2. The following amounts are hereby appropriated for the operation of the Town government and its activities for the Fiscal Year beginning July 1, 2014 and ending June 30, 2015 in accordance with the chart of accounts heretofore established for this Town for the **General Fund**:

SECTION 3. There is hereby levied a tax at the rate of fifteen and a quarter cents (.1525) per one hundred dollars (\$100) valuation of property listed for taxes as of January 1, 2014 for the purpose of raising the revenue listed as current year property taxes in the General Fund in Section 1 of this ordinance.

SECTION 4. The Finance Officer is hereby authorized to transfer appropriations within departmental appropriations. The Finance Officer is not authorized to effect transfers between departmental appropriations or between funds without approval of a budget amendment.


