JULY 1, 2020

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TOWN OF CAPE CARTERET, NORTH CAROLINA, that pursuant to G. S. 159-16;

SECTION 1. The following revenues are estimated to be available in the General Fund for the Fiscal Year beginning July 1, 2020 and ending June 30, 2021.

**SECTION 2.** The following amounts are hereby appropriated for the operation of the Town government and its activities for the Fiscal Year beginning July 1, 2020 and ending June 30, 2021 in accordance with the chart of accounts heretofore established for this Town for the **General Fund**:


**Total EXPENDITURES: \$ 1,632,803**

**SECTION 3.** There is hereby levied a tax at the rate of twenty one and one quarter cents (\$0.2125) per one hundred dollars (\$100) valuation of property listed for taxes as of January 1, 2020 for the purpose of raising the revenue listed as current year property taxes in the General Fund in Section 1 of this ordinance.

**SECTION 4.** The Finance Officer is hereby authorized to transfer appropriations within departmental appropriations. The Finance Officer is not authorized to effect transfers between departmental appropriations or between funds without the approval of a budget amendment.


